

# European Meeting Migration & Development bridges to build, deconstructing stereotypes!



20<sup>th</sup> and 21<sup>st</sup> of November 2008\_Council of Europe in Strasbourg

#### CONTEXT:

International migrations are one of the major challenges of the 21<sup>st</sup> century. They play an undeniable part in the economic, political, social and cultural dynamics of both the industrialised and developing countries. The financial and material transfers, the circulation of skills and knowledge and their impact on the dynamics of development, the increasing differences in wealth and poverty between the North and the South but also the needs for labour... are all factors that make trans-national mobility a major development issue both in the host and home countries and which, on the contrary, should not be considered to be an obstacle to integration and coexistence by national and European public opinion.

Therefore, the question of migration should be seen in a wider context than just the fields of economics and security and cannot be circumscribed solely in terms of restrictive and purely economic measures; it goes beyond the new political thinking in matters of co-development. This is why the IDEM! *Informing on development and migration* project is working to change perceptions of international migrations and their impacts on development in European public opinion by means of an awareness raising campaign among media professionals in order to renew their approaches. IDEM! has been developed since 2006 and is a European project carried out in collaboration with 6 partner organisations (Cospe – Italy, CIDAC – Portugal, Initiatives 21 – Belgium, Connections for development - United Kingdom, FORIM – France and CeiPaz - Spain). The actions developed by the project are, on the one hand, producing information about the contents of the relationship between Migration and Development and, on the other, disseminating it to the various target groups (media professionals, leaders of civil society and political decision makers).

Within this framework, celebrating the European year of Intercultural Dialogue and the French presidency of the European Union, the Institut Panos Paris is organising a meeting at the Council of Europe in Strasbourg, on the 20<sup>th</sup> and 21<sup>st</sup> of November to form a focal point for communicating information, at a European level.

The seminar will be organised around plenary sessions and workshops in sub-groups (15 to 20 people per group) whose central objective will be to define a strategy and a roadmap for renewing the thinking about Migration and development at European level.
